### Description of product

The Three-phase Asynchronous Motor frame size 225 of type series (IE.-)W..R 225... Ex db (eb) (2D).(KN)... and (IE.-)W..R 250... Ex db (eb) (2D).(KN)... is a flameproof encapsulated low-voltage motor in surface-cooled cast iron design. It is equipped with temperature limiters. The connection is made via the terminal box in type of protection flameproof enclosure or increased safety.

### test report

The test results are recorded in the confidential test report IB-24-3-0002 of 2024-09-20. The test documents are part of the test report and they are listed there.

#### *Summary of the test results*

The Three-phase Asynchronous Motor frame size 225 of type series (IE.-)W..R 225 Ex db (KN)... and (IE.-)W..R 250 Ex db (KN)... fulfils the requirements of explosion protection for equipment of Group II, Category 2 G, type of protection flameproof enclosure "db".

The Three-phase Asynchronous Motor frame size 225 of type series (IE.-)W..R 225 Ex db eb (KN)(2D)... and (IE.-)W..R 250 Ex db eb (KN)(2D)... fulfils the requirements of explosion protection for equipment of Group II, Category 2 G, type of protection flameproof enclosure "db" and increased safety "eb" and Category 2 D, type of protection dust ignition protection by enclosure "tb".

The proof of compliance with the temperature class and the maximum surface temperature for the individual motor types is provided in the corresponding test reports of the respective Continuation Sheets to this certificate.

### Special conditions for use

- Repairs of the flameproof joints must be made in compliance with the constructive specifications provided by the manufacturer. Repairs must not be made on the basis of values specified in tables 2 and 3 of EN 60079-1.
- Only fastening screws (property class min. 10.9 or A\*-80), specified by the manufacturer, shall be used according to ISO 4762 be used.
- The Three-phase Asynchronous Motor can be used also in an extended ambient temperature range. This is specified in the respective Continuation Sheet to this EU-Type Examination Certificate and the motor-specific data sheet and on the type plate.
- The rated values and the measures to comply with the temperature class and the maximum surface temperature for dust are specified in the respective Continuation Sheet to this EU-Type Examination Certificate. The instructions and electrical data contained therein, in particular for operation on the frequency inverter, must be observed for the individual motor types.
- The Three-phase Asynchronous Motor can also be marked with a surface temperature for dust deviating from 125 °C if tested accordingly.

- For the construction types IM V6, IM 2131 and IM V19, additional measures must be taken by the user to prevent foreign objects from falling vertically into the fan.
